

EXTERNAL REVIEWERS' PROTOCOL

(Protocol that the journal will make available to its reviewers to improve and facilitate the manuscript review process. For the purpose of proving editorial transparency, the journal is publishing this protocol to make authors aware of the evaluation aspects to which their manuscripts will be subjected.)

The attached template is intended as a guideline for conducting the assessment, but not as a limitation on same. The evaluator may add any aspects to this protocol deemed to be appropriate, in line, where possible, with one of the principles of the Peer Review; that is, to improve the formal presentation and scientific content of a manuscript deemed worthy of favorable assessment.

INFORMATION ON THE EVALUATION PROCESS:

1. The journal *Estudios sobre Educación* is indexed in the following databases: Social Science Citation Index (Thomson-Reuters, USA), SCOPUS (Elsevier, Holland), Fuente Académica (EBSCO, USA); International Bibliography of the Social Sciences (London School of Economics, UK); INIST (CNRS, France), IBZ Online - International Bibliography of Periodical Literature in the Humanities and Social Sciences (de Gruyter, Germany), Latindex (Mexico); IRESIE (Mexico); CREDI (Organization of American States); In-Recs (EC³ Spain); ISCOC (CINDOC, Spain); and Dialnet (University of La Rioja, Spain).
2. The original material received is first assessed by one or more members of the Editorial Committee, to evaluate its suitability in terms of the content encompassed by the journal's remit and the established publication criteria.
3. So as to guarantee quality standards in published articles, and to meet the requirements established by indexed databases, *Estudios sobre Educación* follows an external peer-review system in relation to research topics and methodologies.
4. Original articles (author(s) names removed) are sent by the Editorial Committee to two external reviewers, who deliver their reports. These reports form the basis for the Editorial Committee's decision to reject or accept the article, or to accept a modified version of the article. It is hoped that the evaluation system may be as transparent as possible. Thus, the non-confidential parts of evaluators' reports are sent to the authors, excluding any details that may indicate the identity of the external reviewers. Some formal changes may be made to the text, while at all times respecting its content. Once the changes suggested by the evaluators have been incorporated, the new version is submitted for a second evaluation process.
5. Evaluators' reports are written in line with a Protocol which includes: a) a general recommendation; b) assessment of overall quality; c) evaluation of originality and relevance; d) evaluation of technical and academic content: background, methodology, structure and formal features; e) additional comments.

Recommendations for evaluation reports

1. The evaluations issued are to be well-grounded and clearly explained.
2. In terms of style, personal or pointed expressions or comments, and/or phrases open to any misinterpretation, are to be avoided.
3. The evaluation of the manuscript and the recommendation regarding acceptance or rejection should be congruent.
4. In so far as possible, the positive aspects of the evaluated text should be highlighted and suggestions made regarding how any deficiencies it contains may be corrected.
5. A manuscript is to be rejected when:
 - it is of little or no academic interest or relevance;
 - the validity of its content is compromised by serious methodological failures;
 - the focus is superficial, of a merely descriptive or general-interest nature;
 - the interpretation or organization of information is generally inadequate;
 - the text lacks significant bibliographical and documentary support;
 - the written expression of the text is so inadequate as to require a significant or total re-write.
6. Major corrections will be required in texts:
 - that contain methodological errors which can be corrected without a complete re-drafting of the text;
 - whose academic depth or coherence may be questioned in relation to secondary or supplementary arguments;
 - wherein the approach to questions or information-management requires improvement in certain areas;
 - whose bibliographical or documentary apparatus could be slightly improved;
 - where the written expression is acceptable, although it may contain a range of errors or imprecise terms.
7. Minor corrections will be required in texts:
 - that contain no significant methodological errors;
 - that reach a coherent and detailed standard of analysis, although there may be room for more nuanced discussion;
 - wherein gaps in the bibliographical or documentary apparatus are insignificant;
 - where the written expression is generally good, although a number of small corrections may be suggested.
