BRIEF CURRICULUM VITAE (2023)

Dr. Dr. CARLOS I. MASSINI-CORREAS

Carlos I. Massini-Correas, was born in Mendoza, Argentina, in 1944, and graduated as a Lawyer in 1970, and as a Doctor in Law in 1975 (with honors), in both cases from the University of Mendoza. He's married to María Cecilia Pontis, Licensee in Political Sciences, and has two sons, three daughters and nine grandchildren. In 2000 he obtained the degree of Doctor in Philosophy (Ph.D.) (with honors) in the National University of Cuyo-Argentina. In 2011, CIMC was appointed Doctor Honoris Causa at the University of Mendoza; in 2020 he received the same degree at the Austral University of Buenos Aires, and was appointed as Egregius Magister at the Universidad Panamericana of Mexico. Now, he is Senior Professor of Philosophy of Law at the University of Mendoza, and Professor of the Doctorate in Law in the Universidad Panamericana of México. Besides, he was full professor in the Magister in Philosophy of Law at the National University of Buenos Aires until 2019, and was, until 2007, full professor of Ethics at the Faculty of Philosophy of the Catholic University of Argentina in Buenos Aires and, until 2011, of the Seminar on Philosophy of Law at the Faculty of Philosophy of the University of Cuyo, in Mendoza-Argentina.

Moreover, he has been Visiting Professor and Scholar at the universities of La Coruña, Navarra, Abat Oliva (Spain), Catholic University of Valparaíso, Los Andes, Catholic University of Concepción, and Catholic University of Chile (Chile), Panamericana and National Autonomous (UNAM) in Mexico, Catholic of Medellín, Saint Thomas Aquinas, La Sabana and Sergio Arboleda (Colombia), Paris II (France), Catholic University of Porto Alegre and Federal University of Rio Grande do Sul (Brazil), Münster (Germany), and the Notre Dame-Jacques Maritain Center (EE.UU.), among many others. He made post-doctorate studies in Paris in 1981/82 with Michel Villey and Georges Kalinowski, and in Münster in 1992 with Fernando Inciarte and Werner Krawietz; in this opportunity he won a scholarship from the German Service of Academic Exchange (DAAD).

He has published 33 books in Argentina, Spain, Chile, Brazil, Italy, México, and Peru, and more than 250 articles in Latin American and European scientific reviews, like *Rechstheorie*, *Archives de Philosophie du Droit*, *Anuario Español de Filosofía del*

Derecho, Rivista Internazionale di Filosofia del Diritto, Analogía Filosófica, Problema-UNAM, Ars Iuris, Sapientia, Persona y Derecho, Metafísica y Persona, Ars Interpretandi, Doxa, Humana Iura, Ius Publicum, Intus-Legere, Humanitas, Philosophia-Mendoza, Rivista di Filosofia del Diritto-Journal of Legal Philosophy, Prudentia Iuris, Ethos, Nuntium, Anuario de Dereito, Díkaion, Revista Jurídica Austral, and many more.

He has made many translations of scientific papers into Spanish from English, French, German, and Italian, and directed few collective editions of books on Philosophy of Law and Human Rights. Moreover, he directed many doctorate thesis in Ethics and Philosophy and Law, and is consultant and referee of various scientific reviews of Europe and America, among them: *Problema*, *Tópicos de Filosofía* (México), *Sapientia*, *Prudentia Iuris*, *El Derecho*, *Philosophia* (Argentina), *Persona y Derecho* (Spain), *Humanitas* (Chile), *Díkaion*, *Revista Jurídica Austral*, and Scientific Collections like *Recta Ratio*, among others.

He has been for twenty years Principal Researcher at the National Council of Scientific Research (CONICET) of Argentina, participated in many International Research Projects, in America and Europe, and was member of the Adviser Committee of Philosophy of Law and Politics, and Expert Adviser in the CONICET. Besides, he has been Adviser at the National Commission of Evaluation of Universities (CONEAU), and integrated for many years the Board of the Argentinian Association of Philosophy of Law and of the Thomistic Society of Buenos Aires. He was for many years Academic Secretary of the University of Mendoza, were is now Director of the University Committee of Scientific Ethics. Moreover, he was the Director, for fifteen years, of the Doctorate in Law at the Catholic University of Santa Fe-Argentina. Besides, he was cofounder and for many years vice-president of CONIN Foundation, which struggles against children malnutrition; now, he is a member of the Head Committee of this institution.

In 2016 the Universidad Nacional Autónoma of Mexico published a volume of 636 pages under the title *Filosofía Práctica y Derecho*, as homage of his academic career of more than fifty years. Thirty four scholars from America and Europe had contributed with his articles to the book. And in 2022, the Senate of his native province, Mendoza, gave him a diploma of recognition of his Scientific and Academic career. He is also member of the Academia del Plata, the firs academy of Argentina.
